- To be eligible to apply for an Industry Development Membership, the applicant must be currently operating an amusement facility within the country. Reasonable proof may be requested every calendar year to be eligible to renew the membership within the three-year period.
- The selection of eligible countries and facilities is at the discretion of IAAPA. Decisions are final.
