### INSURANCE

As stated on the exhibit space contract, every exhibitor must provide IAAPA with an insurance certificate. The certificate must include:

- General Aggregate and Per Occurrence limits, minimum amounts noted below
- IAAPA, Orange County Convention Center, Freeman, their entities, subsidiaries, agents, representatives, officers, staff, volunteers and employees, listed as additionally insured for IAAPA Expo 2019, November 14-24, 2019. \*
- Exhibitor Company Name and “dba” name, if applicable
- Certificate Policy Number
- Effective Dates
- IAAPA’s name and address as the Certificate holder: IAAPA, 4155 West Taft Vineland Road, Orlando, FL 32837, USA. \*\*

All policies shall evidence insurance written by a carrier licensed to cover business in the state of Florida and rated at least “A” in A.M. Best’s Key Rating Guide.

Specific insurance requirements are determined by the type of products/services displayed, and in following with the ASTM 747-06 definition of an amusement ride or device (examples: batting cages, climbing walls, inflatables, etc.). Please review the ASTM 747-06 definition and insurance requirements below to determine which level of insurance you will need.

ASTM 747-06:

**Amusement ride or Amusement device: a device or combination of devices or elements that carry, convey or direct a person(s) over or through a fixed or restricted course or within a defined area, for the primary purpose of amusement or entertainment.**

There may be no limitations on which country claims may be brought.

*No exhibitor of whom a certificate of insurance is required will be allowed to move onto the Trade Show floor until such certificate is delivered to IAAPA.*

IAAPA does not recommend or endorse any insurance agency. Exhibitors may use any insurance agency as long as they are licensed to do business in the state of Florida and rated at least "A" in A.M. Best's Key Rating Guide. Please see insurance company options: below PICC (Chinese companies only) and Rainprotection (companies worldwide).
